ELECTION GUIDELINES

1. SHORT TITLE & DEFINITIONS

- 1.1. Pursuant to the powers provided to the Board of Directors under Article 11 (a) of the Articles of Association of the Indian Cricketers' Association (ICA), these Election Guidelines ("**Guidelines**") shall be followed for the conduct of election to the Contested Posts (as defined below).
- 1.2. In these Guidelines, unless the context otherwise requires and subject to Clause 1.3 below:
- 1.2.1. "**Apex Body**" shall mean the apex council of the BCCI and the principal governing body (apex council, management committee, executive committee or however it may be named in the constitution of such BCCI Member) of the relevant BCCI Member, as the case may be;
- 1.2.2. "**Articles**" shall mean the Articles of Association of the ICA, as adopted and amended by the ICA from time to time;
- 1.2.3. "**BCCI**" shall mean the Board of Control for Cricket in India;
- 1.2.4. "**BCCI Constitution**" shall mean the memorandum of association and rules and regulations of the BCCI, as adopted and amended by the BCCI from time to time;
- 1.2.5. "**BCCI Members**" shall mean the cricket associations that constitute the Full Members of the BCCI, defined as such in accordance with the BCCI Constitution;
- 1.2.6. "**Board**" or "**Board of Directors**" shall mean the collective body of the Directors of the ICA;
- 1.2.7. "**Clause**" and "**Sub-clause**" shall mean the clause and sub-clause of these Guidelines;
- 1.2.8. "**Contested Posts**" shall have the meaning ascribed to it under Clause 3.1 below;
- 1.2.9. "**Director**" shall mean a director appointed to the Board of the ICA in accordance with the Articles;
- 1.2.10. "**Draft Electoral Roll**" shall have the meaning ascribed to it under Clause 6.3 below;
- 1.2.11. "**Effective Date**" shall mean the date on which the ICA Board formally approves these Guidelines;
- 1.2.12. "**Election Notification**" shall have the meaning ascribed to it under Clause 5.3 below;
- 1.2.13. "**Election Schedule**" shall have the meaning ascribed to it under Clause 5.4 below;

- 1.2.14. **“Electoral Officer”** shall be the person of such designation duly appointed by the BCCI, and as referred to in the Articles;
- 1.2.15. **“Eligible Candidate”** shall have the meaning ascribed to it under Clause 7.1 below;
- 1.2.16. **“Final Electoral Roll”** shall have the meaning ascribed to it under Clause 6.3 below;
- 1.2.17. **“General Body”** shall mean the body of all the Members of the ICA taken together;
- 1.2.18. **“Governing Council”** shall mean the IPL Governing Council and the Governing Council of the relevant BCCI Members (where existing and applicable);
- 1.2.19. **“ICA”** shall mean the Indian Cricketers’ Association;
- 1.2.20. **“ICA Chapter(s)”** shall mean the separate chapters of ICA that correspond to the jurisdiction of BCCI Members and within which the ICA Members are allocated based on where they hail from;
- 1.2.21. **“ICA Member”** shall mean a person who has been granted and holds membership in and of the ICA:

(A) Class-A: *Class-A ICA Members shall be entitled to exercise rights with regard to voting in elections, contesting elections, insurance and other benefits as provided by the ICA. Class-A shall consist of the following:*

- (i) ICA Members who have paid the subscription fees as applicable to them for a particular Financial Year, before the due dates prescribed by the ICA Board of Directors from time to time for such fees; and*
- (ii) ICA Members who have previously defaulted on payment of subscription fees and have completed a cooling-off period of one year (as prescribed for Class-C Members below) from the date of making payment of the outstanding dues.*

(B) Class-B: *Class-B ICA Members shall not be entitled to exercise any rights with regard to voting in elections, contesting elections, insurance and other benefits as provided by the ICA. Class-B shall consist of the ICA Members who are in default of subscription fees as applicable to them for a particular Financial Year before the due dates prescribed by the ICA Board of Directors from time to time for such fees.*

(C) Class C: *Class-C ICA Members shall be entitled to exercise all the rights as Class-A members except the right to vote or contest in any election. Class-C shall consist of the ICA Members who have paid their outstanding dues as applicable to them for a particular Financial Year after the due date prescribed and are undergoing a cooling-off period of one year from the date of making such payment, in respect of the right to vote or contest in elections*

1.2.22. **"ICA Representative Nominees"** shall mean:

1.2.22.1. The male and female representatives of ICA Members and ICA Chapters that are to be nominated by the ICA to the Apex Bodies of the BCCI and BCCI Members, respectively; and

1.2.22.2. The representatives of ICA Members that are nominated by the ICA to the Governing Councils of the BCCI and BCCI Members (where applicable);

1.2.23. **"IPL"** shall mean the Indian Premier League;

1.2.24. **"Nominated Candidates"** shall have the meaning ascribed to it under Clause 7.15 below;

1.2.25. **"Nomination Policy"** shall mean the policy for nomination of ICA Representative Nominees to BCCI and BCCI Members as duly adopted and approved by the ICA from time to time;

1.2.26. **"Office Bearers"** shall mean the office bearers of the ICA; and

1.2.27. **"Website"** means the official website of the ICA as located at www.indiancricketersassociation.com.

1.3. Any capitalised terms used herein and not defined in these Guidelines shall have the meaning ascribed to them in the Articles or the Nomination Policy.

2. SCOPE, APPLICABILITY AND AMENDMENT

- 2.1. These Guidelines shall come into effect on the Effective Date.
- 2.2. These Guidelines shall be followed for the conduct of election for the Contested Posts that are vacant or become vacant after the Effective Date.
- 2.3. These Guidelines have been approved by a resolution of the Board of Directors and may only be amended in accordance with the Articles.

3. ELECTIONS FOR CONTESTED POSTS

- 3.1. Elections may be held for the posts specified for the ICA Office Bearers under Article 8(a) of the Articles and for ICA Representative Nominees under Article 13(b) of the Articles and as due for election or required to be filled through election in accordance with the Articles or the Nomination Policy ("**Contested Posts**").
- 3.2. The requisite eligibility criteria and eligible voting electorate for the ICA Office Bearers is provided in the table below:

- 3.3. Article 8 (c) of the Articles provides that at least 1 (one) of the Office Bearers shall be a woman. In the event that a female candidate is not elected as a President, Secretary or Treasurer, the female candidate who receives the highest number of votes for the post of Member Representative would stand elected as a Member Representative, even if one or more male candidates receive higher votes than such female candidate.
- 3.4. The requisite eligibility criteria and eligible voting electorate for the ICA Representative Nominees shall be specified in the Nomination Policy.

4. MANNER OF ELECTION

- 4.1. The election will ordinarily be conducted via e-voting or in person by secret ballot as determined by the Electoral Officer, in accordance with the Articles and the procedure prescribed in these Guidelines and in the Election Notification.
- 4.2. The election will be overseen and supervised by the Electoral Officer.

5. ELECTION NOTIFICATION

- 5.1. The election process for Contested Posts shall commence with the issuance of the Election Notification.
- 5.2. The Electoral Officer shall, at least twenty one (21) days prior to the date fixed for election, cause the Election Notification to be issued on the Website and cause it to be forwarded to all ICA Members.
- 5.3. The Election Notification shall include an Election Schedule, a complete list of Contested Posts for which elections shall be held and the terms for which such posts will be held, a list of ICA chapters that shall elect male and/or female ICA Representative Nominees based on the criteria specified in the Nomination Policy, draft Electoral Roll and a call to file nomination applications (collectively, “**Election Notification**”).
- 5.4. As part of the Election Notification, the Electoral Officer shall include an Election Schedule with specific timelines and deadlines for the different election steps (“**Election Schedule**”). The Election Schedule will follow the broad timelines as specified in these Guidelines. However, The Election Officer will be allowed to modify the timelines if required, based on exigent circumstances. An indicative Election Schedule framed in accordance with these Guidelines is provided below.

6. PREPARATION OF ELECTORAL ROLL

- 6.1. The Electoral Officer shall release a draft electoral roll, consisting of all Class-A ICA Members, on the Website along with the Election Notification ("**Draft Electoral Roll**").
- 6.2. The Electoral Officer will provide a time period of at least three (3) days and the procedure to submit objections regarding the composition or constitution of the Draft Electoral Roll. The Electoral Officer shall review such objections and dispose them as necessary.
- 6.3. The Electoral Officer shall, within three (3) days of the deadline for receipt of the objections as per Clause 6.2 above, prepare a final electoral roll ("**Final Electoral Roll**"). The Final Electoral Roll shall be published on the Website in accordance with the Election Schedule.
- 6.4. Only the individuals named in the Final Electoral Roll shall be eligible to vote and contest for election to the Contested Posts as specified below.

7. NOMINATION OF CANDIDATES

- 7.1. Any individual whose name is included in the Final Electoral Roll, who satisfies the eligibility criteria for a particular Contested Post and who is otherwise not disqualified under the Articles or as per these Guidelines will be an Eligible Candidate ("**Eligible Candidate**").
- 7.2. The Election Notification will contain an invitation from the Electoral Officer inviting nomination applications from Eligible Candidates who wish to contest for the Contested Posts. The Eligible Candidates will be given at least three (3) days after the publication of the Final Electoral Roll to file nomination applications.
- 7.3. The nomination applications must be submitted as per the timeline specified in the Election Schedule and in the form and manner prescribed in Annexure 1 to Annexure 4 below (which will also be appended to the Election Notification).
- 7.4. The nomination application of a candidate, shall be proposed by one (1) other person that is included in the Final Electoral Roll and is eligible to vote for the concerned Contested Post and seconded by one (1) other person that is in the Final Electoral Roll and is eligible to vote for the concerned Contested Post, using Annexure 2 to Annexure 4 (as the case maybe) attached herewith. The candidate so proposed and seconded shall provide a declaration accepting such nomination as per Annexure 2 to Annexure 4 (as the case maybe) attached herewith.

- 7.5. No person shall be eligible to nominate more than one (1) candidate for the same Contested Post, either as proposer or seconder; and, if they so do, their signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- 7.6. No person shall be permitted to withdraw their name as proposer/seconder, once the nomination paper subscribed by them has been delivered to the Electoral Officer.
- 7.7. An Eligible Candidate shall be entitled to contest for only one (1) Contested Post during the election.
- 7.8. An Eligible Candidate will be considered for listing as a Nominated Candidate only if they submit a complete application and meet all the requirements specified, as determined by the Electoral Officer. Any nomination application that is submitted after the deadline specified in the Election Schedule shall not be considered by the Electoral Officer.
- 7.9. The Electoral Officer reserves the right to require further information or seek clarification on and in respect of any matter relating to the nomination application or the election.
- 7.10. Scanned and original copies of all eligibility documentation prescribed in the Election Notification are required to be sent to the Electoral Officer in the manner and timeline stated in the Election Notification.
- 7.11. Upon scrutiny of the nomination applications to the satisfaction of the Electoral Officer, the Electoral Officer shall within three (3) days of the filing of nomination applications release a draft list of duly Nominated Candidates on the Website in accordance with the Election Schedule.
- 7.12. A period of at least three (3) days shall be provided for the submission of objections, in accordance with the procedure specified, regarding the composition or constitution of the draft list of duly Nominated Candidates.
- 7.13. During the time period specified in Clause 7.12 above, the candidates shall be entitled to withdraw their candidature. Notice of withdrawal of candidature shall be submitted to the Electoral Officer in the form prescribed in Annexure 5 by following the procedure as prescribed under Clause 7.12 above. Notice of withdrawal of candidature shall be final and may not be reversed.
- 7.14. Where the number of Nominated Candidates for any Contested Post, in the final list of Nominated Candidates is equal to the number of posts to be filled, all such Nominated Candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election to such post.
- 7.15. Within two (2) days of the deadline for receipt of objections as per Clause 7.12 above and withdrawal applications filed as per Clause 7.13 above, a final list of Nominated Candidates shall be prepared after the Electoral Officer addresses and disposes of such objections and withdrawal applications. The final list of Nominated Candidates shall be published on the Website in accordance with the Election Schedule ("**Nominated Candidates**"). The Electoral Officer shall also specify the Contested Posts for which more than 1 (one) candidate was nominated and consequently for which polling would be held.

- 7.16. Once the final list of Nominated Candidates has been published, no withdrawals of candidature shall be permitted.

8. KNOW YOUR CANDIDATE INFORMATION SHEETS

- 8.1. With a view to providing a level playing-field to all Nominated Candidates and in the interests of those on the Final Electoral Roll making informed and educated voting choices, all Nominated Candidates will be invited to submit information statements summarising their agendas, qualifications and policies for the ICA in writing.
- 8.2. All such information statements received will be consolidated and published by the Electoral Officer on the Website in accordance with the Election Schedule, within three (3) days of the publication of the final list of Nominated Candidates.

9. ELECTION CODE OF CONDUCT

- 9.1. Nominated Candidates will not use unfair means including bribery, or appeal to or use of religious symbols, nor distribute gifts of various kinds such as liquor, to induce voters for support. They will strictly adhere to the prescribed campaign information practices specified in Clause 10 below.
- 9.2. Proxy voting shall not be allowed.
- 9.3. No materials shall be circulated that is designed to appeal to religious, caste, or communal sentiments to entice for votes and all materials shall remain compliant with all laws in force.
- 9.4. All Nominated Candidates are expected to cooperate with the Electoral Officer and their designated staff for smooth conduct of voting during the entire process.

10. INFORMATION PRACTICES

- 10.1. All Nominated Candidates shall comply with the following practices:
- 10.1.1. Candidates shall conduct themselves in a fair and reputable manner and, more generally, in a spirit of respect for fundamental ethical principles.
- 10.1.2. Candidates shall conduct themselves with dignity and moderation and with due respect to other candidates, the ICA and the Final Electoral Roll members. A candidate may produce no spoken word, written text or representation of any nature likely to harm the personal image of another candidate or cause them prejudice. Criticism of other candidates, when made, shall be confined to their policies and programmes, past record and work. Criticism based on unverified allegations or distortion shall be avoided. There shall be no appeal to caste or communal feelings for securing votes.
- 10.1.3. Candidates shall avoid excessive expenditure in relation to advancing their candidature, recognising that it could become a factor of inequality amongst the candidates.

- 10.1.4. No public meeting or gathering of any kind may be organised in the framework of promoting a candidature. No use, free of charge or in return for payment, of the services of a journalist or the media may be made in order to place a candidate at an advantage or a disadvantage.
- 10.1.5. All candidates shall avoid scrupulously all activities that are “corrupt practices”, such as bribing of voters, intimidation of voters, impersonation of voters, etc.
- 10.1.6. Candidates may in no case and under no pretext give presents, offer donations or gifts or grant advantages of whatever nature, directly or indirectly, to voting members or their representatives.
- 10.2. In order to ensure neutrality and independence:
 - 10.2.1. As the voting is secret, Final Electoral Roll members are prohibited individually or collectively, from announcing publicly in any form whatsoever their intention to vote or not vote for a Nominated Candidate.
 - 10.2.2. Candidates may not accept mandatory instructions from any public or private, natural or legal person. No direct or indirect assistance, be it financial, material or in kind, be it direct or indirect, may be given to candidates by any third party. Candidates may not enter into any form of undertaking with any natural or legal person likely to affect the neutrality and the freedom of decision or action of their future post.
 - 10.2.3. ICA’s executive team and administration shall maintain a strict duty of neutrality at all times. No support or service in relation to a candidature may be requested from nor be given by any member of the ICA’s administration or staff.

11. VOTING AND DECLARATION OF RESULTS

- 11.1. The elections to the Contested Posts shall commence at least two (2) days after the publication of the know your candidate information sheets as per Clause 8.
- 11.2. The Electoral Officer shall cause arrangements to be made for e-voting/secret ballot by Final Electoral Roll members on the day(s) of the election as specified in the Election Schedule and will call the Final Electoral Roll members to exercise their voting right in respect of each of the Contested Post for which polling would be held.
- 11.3. The Electoral Officer will prescribe the procedure for the Final Electoral Roll members to cast their vote including, the sequence according to which posts shall be up for election, the maintenance of secrecy of votes, the time limit for exercising the voting right, etc.
- 11.4. At the closure of the time prescribed for voting, the Electoral Officer shall cause the counting, auditing and verification of the votes cast and announce the results in respect of each of the Contested Posts, within two (2) days after the end of polling.
- 11.5. After announcement of results, the Electoral Officer shall announce the completion of the poll process.

12. DATA RETENTION

- 12.1. Digital records of all communication, emails and attachments received by the Electoral Officer shall be encrypted as soon as possible after the announcement of results and retained by the Electoral Officer.
- 12.2. Records of all physical documentation submitted by ICA Members and Nominated Candidates for the election will be sealed and handed over to the ICA as soon as possible after the announcement of results.
- 12.3. Digital records will be decrypted and/or physical records unsealed only in the event that the elections are subject to legal proceedings and the records contain any evidence or information that is relevant to such legal proceedings.
- 12.4. In the event that the digital and physical records are not required in legal proceedings, the records will be destroyed after a period of 3 (three) months from the date of the announcement of results.
- 12.5. In the event that the digital and physical records are required in legal proceedings, the records will be destroyed after a period of 3 (three) months from the final conclusion of such legal proceedings.

13. DISPUTE RESOLUTION

- 13.1. In case of any disputes or objection arising with respect to the election, from the declaration or publication of electoral rolls to the declaration of results including but not limited to objection to candidacy, disqualification, eligibility to vote or the admission or rejection of a vote, the Electoral Officer shall decide the same and such a decision shall be final and conclusive.

<p>i) A Nomination-cum Affidavit form, in the prescribed “Form C” provided in Annexure 4 to these Guidelines, duly completed by the applicant with signatures of the applicant, a proposer and seconder (each of whom are also included in the Final Electoral Roll in the same ICA Chapter as the applicant filing the nomination and are not proposer or seconder to more than one candidate in respect of one (1) Contested Post) being duly attested by notary/oath commissioner.</p> <p>ii) If the applicant is employed by a Government/Public Sector undertaking under ‘Sports Quota’, a certificate from such Government/Public Sector employer stating that the applicant is employed under ‘Sports Quota’.</p> <p>iii) If the applicant has held any Office Bearer posts in the BCCI or any BCCI Member previously, a sheet specifying such positions held along with the terms and tenures of such positions.</p>
